The summit consists of four key components:

- **Friends of Medicine Luncheon** hosted by the Parliamentary Friends of Medicine and the Patient Voice Initiative to discuss the importance of the patient voice in the Australian health system;
- **Patient meetings with MPs and Senators** in which patients will share their lived experiences with their Federal Member of Parliament to highlight how timely access to innovative medicines has impacted their lives; and
- Shaping Healthcare Together annual roundtable, where we will discuss key issues related to consumer/patient engagement and the HTA review with the leaders of 20 Australian patient organisations.

The Patient & Parliament Summit provides a unique combination of information and insight exchange together with the opportunity to connect patients directly with parliamentarians.

Hayley Andersen, Head of Advocacy & Policy, Bristol-Myers Squibb said: "Truly effective reform of our healthcare system requires the active involvement and insights of those it serves - the patients.
