# Becoming a Successful Applicant

We know that Graduate Programmes can be competitive, but we want you to be successfull when you apply for the role. Having this in mind, we would like to give you some hints and tips on how to make your application stand out.

# Reflect

Think of your future self and understand if Bristol Myers Squibb is a company you would like to work for. Before even thinking about the role you want to apply within the Graduate Scheme, do a large scale investigation of the company, the work culture, our mission, vision and values. This will give you a very good overview of the company you are applying for.

# Decide

By now, you have read about Bristol Myers Squibb and you came to a conclusion that you would like to work with us. This is great news! It is time now for you think of the position you would like to apply. As you can only apply to one position, it is important that you think what do you see yourself doing. Are you undecided between 2 positions? Think which positions makes you more excited on the moment, but as well in 5 years.



## Maximise

Your application documents will be very important (CV and Pitch). On your CV, highlight your job experience (volunteering experiences, college jobs, etc.. these are highly valuable skills), as well your achievements and skills attained. On the interview, be ready to explain what you have learned during college and during your past work experience.

On your pitch, either a video, audio or written essay, make it easy to identify the value you will be talking about. This will help the reader to follow your line of thought and create quicker a connection with you. Make sure you write about you and not anyone else experience/example. The pitch helps us understand if you will be a good cultural fit to the comapny.

A cover letter is optional. If you decide to write one, use it to explain more in detail your CV.

Join our CV and Interview skills sessions. On this event, you will have the chance to learn how to write the ideal CV, as well as understand the interview process so you will be able to ace the application process.

# **FAQ**

Q: I have uploaded my application on the link but I did not receive a confirmation email. Was my application indeed uploaded?

A: Yes. After you upload, you receive a screen saying that your file was submitted. If for some reason it fails, please reach out to early.careers@bms.com

Q: I have applied a few weeks ago already. When will I hear about my application?

A: The application process is open until the 6th of March 2023. You should hear about your application result starting in middle of March, even if you are not successful candidate.

Q: I am graduating in 2023, but I only graduate after the start date of the scheme. Can I still apply?

A: No. You need to have your course completed before the start date (13th of September 2023).
