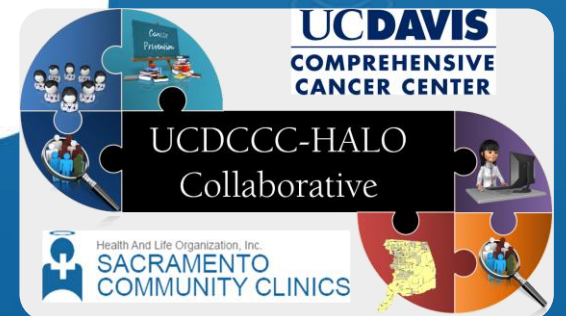

Project progress to date

- Established monthly Collaborative Steering Committee meetings
- Implemented provider and medical assistant training for HPV & cervical cancer; breast cancer; tobacco cessation
- Working to “fix” discrepancies between EMR software vendor and direct extractions from EMR
- Collaborating with Sacramento County Division of Public Health in ending the perinatal transmission of Hepatitis B and promoting newborn vaccinations for newborns, sparing the next generations of Sacramento County residents from HBV-associated liver cancer

Key Challenges

Describe the challenges your project has faced in regards to working across care settings (creating partnerships, referral pathways, coordination/navigation, referral, retention etc.) that you would like to get feedback on from the external advisors.

- Difficulty extracting data due to limited features of electronic health record (EHR) system used by FQHC-look-a-like
- Certain evaluation measures are limited by the use of specific ICD-10 and CPT codes
- Providers of a FQHC-look-a-like feel overburdened – difficult schedule and coordinate an additional training only for providers
- Turn-over of clinical staff at FQHC-look-a-like makes collecting post-test survey a challenge
